China tightens export controls on lithium batteries and graphite materials, reshaping the global EV and energy storage supply chain.

What is China's Lithium battery export control policy?

The export control policy marks a strategic transition for China's lithium battery sector--from rapid, unrestrained global expansion toward controlled, innovation-driven growth.

How big is China's energy storage industry?

Data from the China Energy Storage Alliance (CESA) shows that in the first half of 2025, global energy storage cell shipments reached 246.4 GWh, up 115% year-on-year. Remarkably, Chinese companies accounted for over 93% of this total. Overseas shipments by Chinese manufacturers reached 111.5 GWh, making up 45% of their total output.

What is China's new export control rule?

China also signaled openness to dialogue through bilateral export control mechanisms, aiming to promote transparency, facilitate compliant trade, and ensure that legitimate exports remain uninterrupted. Under the new rule, exporters must apply for licenses from MOFCOM before shipping any controlled items.
